Ordinance No. 2011-3

AN ORDINANCE OF THE CITY OF INGRAM, TEXAS, AMENDING ORDINANCE NO. 110607, EFFECTIVE 11/6/2007, REGARDING LAND USE AND SETBACK LINES FOR RESIDENTIAL AND COMMERCIAL PROPERTY AND REGULATING MOBILES HOMES, MANUFACTURED HOMES AND INDUSTRIALIZED HOMES, TO AMEND THE NUMBER OF SQUARE FEET OF LAND REQUIRED FOR CONSTRUCTION OF RESIDENTIAL UNITS.

WHEREAS, the city is charged with the authority, duty and responsibility of protecting the health, safety and general where welfare of the citizens of the city of Ingram; and

WHEREAS, the city of Ingram having previously found that appropriate regulations for land use and setbacks for residential and commercial properties enhance the general welfare and the value of property within the city of Ingram; and

WHEREAS, certain ambiguities in the existing regulations have led to confusion in their application;

NOW, THEREFORE, be it ordained by the City Council of the City of Ingram, as follows:

SECTION 1:

City of Ingram Ordinance No. 110607, "Section II – Restrictions on Use of Land, subsection B." is hereby amended as follows:

B. If a lot or parcel is larger than 10,000 square feet in size, each residential units shall be allocated 10,000 square feet of land. Newly developed subdivisions must comply with the subdivision regulations of the city's Ingram and this ordinance. Where there is a conflict, the terms of this Ordinance will prevail.

The remainder of City of Ingram Ordinance No. 110607 remains unchanged.

SECTION 2:

The City Secretary shall give notice of this Ordinance by publication in the local newspaper pursuant to applicable laws.
