a) PUBLIC HEARING: Proposed 2026 Tax Rate

b) Discussion and possible action to propose the City of Ingram's 2026 property tax rate by record vote

Per Tax Code §26.05(a), this vote must be a record vote, with each Council Member's vote recorded individually (verbal roll call).

If the proposed rate exceeds the no-new-revenue rate (\$0.3702/\$100), Tax Code §26.05(b) requires this specific motion:

"I move that the property tax rate be increased by the adoption of a tax rate of \$____/\$100, which is effectively a ____% increase in the tax rate."

Upon approval of a proposed rate, notice of the date, time, and location of the meeting at which the City Council will vote on final adoption of the tax rate will be published in the West Kerr Current, as required by the Texas Tax Code.

c) Fiscal Year 2027 Budget Presentation and discussion

This year, staff is reviewing the budget item by item, instead of just looking at department totals like in past years. In the past, a lot of expenses were placed into general, catch-all categories, like Non-Departmental or Other. This year, we are checking each expense to see: where it was listed before, whether it is a cost that happens only once or one that happens every year, and where it truly belongs going forward. You may also notice that the same type of expense, like a phone bill or a repair cost, can show up under more than one department. That is normal — different departments can each have their own version of the same kind of expense, and each one is budgeted separately.

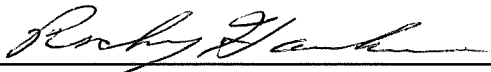
